

ORDINANCE NO. XII

AN ORDINANCE FIXING THE REGULAR MEETING DATE AND PLACE OF THE CITY COMMISSION OF HUNTER'S HOLLOW, BULLITT COUNTY, KENTUCKY.

Be it Ordained by the City of Hunter's Hollow, Bullitt County, Kentucky:

SECTION ONE: The regular meetings of the City Commission of the City of Hunter's Hollow, Bullitt County, Kentucky, shall henceforth be held on the 3rd Tuesday of each month at 7:00 P. M. at the North Bullitt Branch of the Ridgway Memorial Library.

SECTION TWO: Effective Date: This Ordinance shall become effective upon its second reading, approval, and publication in conformance with KRS Chapter 424.

SECTION THREE: All ordinances or parts of ordinances in conflict with this Ordinance or any part of this Ordinance are repealed.

SECTION FOUR: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.
