

ORDINANCE NO. 985-XXV

AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR JULY 1, 1985, THROUGH JUNE 30, 1986, FOR THE CITY OF HUNTERS HOLLOW, BULLITT COUNTY, KENTUCKY.

WHEREAS, on the 16th day of April, 1985, the City Council of the City of Hunters Hollow, Bullitt County, Kentucky, did adopt Ordinance No. 985-XX, an ordinance adopting the Annual Budget for the City of Hunters Hollow, Bullitt County, Kentucky, for the fiscal year July 1, 1985, through June 30, 1986, and;

WHEREAS, it is now necessary to amend said budget to reflect accurately the revenues received and the expenditures made,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Hunters Hollow,

SECTION I: The annual budget for the fiscal year beginning July 1, 1985, and ending June 30, 1986, is hereby amended to read as follows:

SECTION II: This Ordinance shall take effect upon publication.


SECTION III: This Ordinance shall be published according to law.
