

ORDINANCE NO. 985-46

AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR JULY 1, 1986 THROUGH JUNE 30, 1987, FOR THE CITY OF HUNTERS HOLLOW, BULLITT COUNTY, KENTUCKY.

WHEREAS, on the 17th day of June, 1986, the City Council of the City of Hunters Hollow, Bullitt County, Kentucky, did adopt Ordinance No. 985-33, an Ordinance adopting the annual budget for the City of Hunters Hollow, Bullitt County, Kentucky, for the fiscal year July 1, 1986, through ~~July~~ <sup>JUNE</sup> 30, 1987; and

WHEREAS, it is now necessary to amend said budget to reflect accurately the revenue received and the expenditures made,

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Hunters Hollow, as follows:

SECTION I: The annual budget for the fiscal year beginning July 1, 1986 and ending June 30, 1987, is hereby amended to read as follows:
