ORDINANCE NO. 985-46

AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR JULY 1, 1986 THROUGH JUNE 30, 1987, FOR THE CITY OF HUNTERS HOLLOW, BULLITT COUNTY, KENTUCKY.
