ORDINANCE NO. 985-54

AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR JULY 1, 1988 THROUGH JUNE 30, 1989, FOR THE CITY OF HUNTERS HOLLOW, BULLITT COUNTY, KENTUCKY.
