## ORDINANCE NO. 985-56

AN ORDINANCE LEVYING PERSONAL PROPERTY ADVALOREM TAXES AND PROVIDING FOR ASSESSMENT, EQUALIZATION AND COLLECTION IN ACCORDANCE WITH KRS 92.280, ET. SEQ.

BE IT ORDAINED, by the City Council of the City of Hunters Hollow, Bullitt County, Kentucky, as follows:

SECTION ONE: That a personal property advalorem tax of \_\_\_\_\_ on each \$100.00 of value of all personal property taxable for municipal purposes, except property assessed by the State, in said city is hereby levied for the year 1990 as of January 1, 1990.

SECTION TWO: Said levy is made for the purpose of raising revenue to pay salaries of officers and employees, for the repair and maintenance of street and public ways and public buildings in said city, to pay for lighting city streets and to pay all proper charges and legal demands against the City.

SECTION THREE: That the assessment made by the Bullitt County Property Valuation Administrator for state and county purposes for 1990 shall be and is hereby adopted as the assessment for City purposes. These taxes as they relate to motor vehicles and boats shall be collected by the Bullitt County Court Clerk as provided by KRS 132.487 et. seq.

SECTION FOUR: That the City Clerk be and she is hereby directed to forward to the Department of Property Valuation, 592 East Main Street, Frankfort, Kentucky 40601, a 1990 Motor Vehicle Tax Rate Certification for the year 1990.

SECTION FIVE: The City Clerk is directed to advertise the above as provided by law.

SECTION SIX: All payments of taxes provided for herein shall be received by the City Clerk/Treasurer at the business office of City of Hunters Hollow, 11300 Angelina Road, Louisville, Bullitt County, Kentucky 40229.

SECTION SEVEN: Should any section, clause, line, paragraph, or part of this Ordinance to be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

SECTION EIGHT: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.
