## **ORDINANCE NO. 985-111**

AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF HUNTERS HOLLOW, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Hunters Hollow, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Hunters Hollow, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Hunters Hollow, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory annexed is described as follows:

Beginning at a stake in west line of Blue Lick Road at the Northeast corner of the tract described in a deed of correction dated January 25, 1965, recorded in Deed book 111, Page 132 conveyed to Christian H. Glanz, Jr., and running thence with line of said lot N. 77 50'30" w. 400 feet and N. 22 40'W. 250 feet to line of tract conveyed Christian H. Glanz, Jr., etc., by deed dated January 25, 1965 recorded in Deed Book 111 Page \_\_\_\_\_: thence, with the line of said tract N. 77 50'30" E. 400 feet to the Blue Lick Road; thence with same S. 22 40'E. 250 feet to the point of beginning.

The surveys of the land described herein were made on January 14, 1965 by Charles W. Brown.

SECTION II: The City Council of the City of Hunters Hollow, Bullitt County, Kentucky, does find the property described above is of an urban character which is suitable for development purposes without unreasonable delay and does hereby declare it desirable to annex into the City of Hunters Hollow.

SECTION III: The Mayor of the City of Hunters Hollow, Bullitt County, Kentucky, having received prior written consent of each owner of record of the land herein before described requesting annexation into the City of Hunters Hollow, and all provisions of KRS 81A.412 having been complied with, the herein before described property is annexed into the City of Hunters Hollow, Bullitt County, Kentucky.

SECTION IV: This Ordinance shall be published according to law.

SECTION V: This Ordinance is enacted pursuant to KRS 81A.400, et.seq.

SECTION VI: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

SECTION VII: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of the Ordinance.
