## ORDINANCE NO. 985-XXXIII

AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR JULY 1, 1986, THROUGH JUNE 30, 1987, FOR THE CITY OF HUNTERS HOLLOW, BULLITT COUNTY, KENTUCKY.

WHEREAS, on the 17th day of June, 1986, the City Council of the City of Hunters Hollow, Bullitt County, Kentucky, did adopt Ordinance No. 985-XXI, an Ordinance adopting the annual budget for the City of Hunters Hollow, Bullitt County, Kentucky, for the fiscal year July 1, 1986, through July 30, 1987; and
