ORDINANCE NO. 2023-01

AN ORDINANCE OF THE CITY OF HUNTERS HOLLOW ESTABLISHING REGULATIONS FOR THE USE AND ENJOYMENT OF PUBLIC LAND OWNED BY THE CITY OF HUNTERS HOLLOW.

WHEREAS, the City of Hunters Hollow was conveyed a tract of undeveloped real estate by the Hunters Hollow Homeowners Association, Inc. as shown by deed recorded in Deed Book 235 Page 82 and Deed of Correction recorded in Deed Book 313 Page 252, and

WHEREAS, the City of Hunters Hollow believes it is necessary to establish rules and regulations for the use of this City owned public land to protect the general public, to protect the land for compatible public use and enjoyment, and to establish the basic standards for use and protection of this public land, now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUNTERS HOLLOW:

SECTION ONE: All undeveloped and undevelopable real estate that is owned by the City of Hunters Hollow shall be considered as public lands and subject to these rules, regulations and restrictions.

SECTION TWO:

- a) Recreational Activities:
 - 1) Sledding and ice skating. It shall be unlawful for any person to sled or ice skate within the boundaries of any City of Hunters Hollow public land, except in any areas specifically designated for such activity. Provided, that this section shall not apply to any person participating in search and/or rescue or other emergency operations, or to employees of the City of Hunters Hollow or other agencies while performing official duties.
 - 2) Hunting, fishing, or trapping. It shall be unlawful for any person to hunt, fish, or trap wildlife within the boundaries of any public lands; except in areas specifically designated for such activities. Provided, that this section shall not apply to any person participating in search and/or rescue or other emergency operations to locate, contain and remove sick and dangerous animals while performing official duties.
 - 3) Operation of bicycles, skateboards or skates. No person shall operate a bicycle, skateboard, or skates on any section of public land, except on a roadway, in areas designed for parking, or on trails and in other areas specifically designated for such activities.

(B) Motor vehicles.

(1) Other motor vehicles. No operator of a motor vehicle, which shall include all-terrain vehicles, shall operate the vehicle on any public land; except on a roadway or in a parking area. However, this prohibition shall not apply to an emergency vehicle.

(C) Other restrictions.

(1) Burning.

- (a) For the purpose of this section "open fire" shall mean any intentionally ignited bonfire, recreational fire, or those or any other similar burn conducted by any other person in the open air on public lands within the boundaries of City of Hunters Hollow.
- (b) No person shall kindle or maintain an open fire within any public land in the City of Hunters Hollow, with the exception of: (1) recreational fires in area specifically designated for such fires, and only if approved in advance by the Mayor and the Fire Chief of the Fire Protection District, as the case may be.

SECTION THREE: Closing Hours

The public lands owned by the City of Hunters Hollow shall close for any use at 11:00 p.m. and shall remain closed until 6:00 a.m. It shall be unlawful for any person other than police, fire and other emergency service personnel, public utility personnel, and City of Hunters Hollow personnel, while on official business only, to enter upon any Public land owned by the City of Hunters Hollow during hours when such public land is closed. Except in the case of an emergency, as determined by the Mayor who shall provide notice to the public of closing hours and may change the closing hours when necessary.

SECTION FOUR: The public land owned by the City of Hunters Hollow shall not be used for the purpose of any fireworks display at any time

SECTION FIVE: This Ordinance shall be published according to law and be effective thereafter.

SECTION SIX: Any Ordinance or part of Ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

SECTION SEVEN: Should any section, line, or part of this Ordinance be declared unconstitutional or invalid that shall not affect the remainder of this Ordinance.
